

# MY DOCUMENTS LOCATOR

A checklist of personal documents and other useful information

My Document Locator (MDL) is intended to facilitate the location of important documents and information in the event of death or incapacity. Its only purpose is to address the practical difficulties of coping with financial queries at a time when close relatives may be distressed.

MDL is not a Will and should not be regarded as such. It should not contain instructions about what should be done with your money or possessions. It is simply a record of where your key personal records, assets and papers can be located. If you have not made a Will, you are advised to consider doing so.

It is suggested that a responsible adult is made aware of the existence/location of this record and/or a copy should be given to a close relative/executor as a precaution against a common calamity. It is important that the record be kept up to date.
